DIRECTIVE ON DIRECTORATE OF HEALTH CULTURE AND SPORTS
OPERATIONS

Scope

ARTICLE 1- This Directive shall regulate the organization, administration, activity areas and powers and responsibilities of Directorate of Health, Culture and Sports of Yaşar University, which is established in accordance with the regulations on Higher Education Institutions Medico-Social Health, Culture and Sport Affairs Department Practice Directive, the Decree Law on the Administrative Organization of Higher Education Institutions and general provisions on the organization, administration and works, powers and responsibilities of the authorities of the Directorate of Health, Culture and Sports and pursuant to Articles 46 and 47 of the Law No. 2547, amended by Law no. 2880.

Aim

ARTICLE 2 - The aim of this Directive is to meet the demands of university students, student communities and staff to the sports services; psychological counseling and guidance services and health care services.

Definitions

ARTICLE 3 - In this directive,

- a) University refers to: Rector of University,
- b) Directorate refers to: Directorate of Health, Culture and Sports unit which provides services to meet the needs of students and staff on health, sports and culture, and supports education at the same time.
- c) Rector refers to: Rector of Yaşar University,
- d) Board of Trustees refers to: Board of Trustees of Yaşar University.

Administrative Structure of the Directorate

ARTICLE 4 - (1) The directorate consists of the Director, vice director, sports activities specialist, specialist and secretary under the authority of the Secretary General.

(2) The Director, shall be appointed by the Rector with the opinion of the Board of Trustees and the proposal of the Secretary General.

(3) The vice director and other staff shall be appointed by the approval of the Rector and with the proposal of the director and the opinion of the Secretary General.

(4) The budget draft of the Directorate shall be submitted by the director to the Secretary General for the approval of the Rectorship by the end of July at the latest.

Duties and Powers of the Director

ARTICLE 5- (1) The duties and powers of the Director are as follows;

- a) To carry out services related to health care and treatment of students and staff,
- b) To organize activities to meet the sports, cultural and social needs of students and staff.
- c) To provide students with healthy living habits supporting their social, cultural, physical and spiritual development as well as their academic life.
- d) To ensure that Yaşar University students and employees will be involved in activities that will enhance the campus life while developing their existing skills and gaining new skills and to make the sport culture a tradition.
- e) To adopt the social, cultural, sporting and artistic activities, introducing the university culture for our preparatory class students, and introducing academic life for 1st grade students, with different orientation programs organized at the beginning of each academic year.

Fields of Activity of the Directorate

ARTICLE 6 - (1) The Directorate provides services in the following fields of activity:

- a) Health care services
- b) Sports services,
- c) Psychological counseling and guidance services
- d) Student communities,
- e) Campus facilities.

Health Care Services

ARTICLE 7 - (1) The directorate serves the academic staff and the students through the health staff working in the health unit in the campus.

Sports Services

ARTICLE 8 - (1) The sports services provided by the Directorate, the use of indoor and outdoor sports facilities within the campus area are only for university students and staff and are as follows;

- a) To give students the habit of doing sports, to ensure that the training is done regularly,
- b) To provide national and international representation of our University by establishing teams,
- c) To respond to the needs of sports activity of communities, students and staff.

Psychological Counseling and Guidance Services

ARTICLE 9 - (1) The Directorate assists, informs and organizes conferences in the health unit within the campus, in the treatment of mental health of university staff and students with the help of specialized staff.

Student communities

ARTICLE 10 - (1) The Directorate helps the students registered in our University to increase their activities in the social life by establishing communities in line with their interests and abilities.

Campus facilities

ARTICLE 11 - (1) The Directorate provides services to the students and staff in the indoor and outdoor sports facilities and dance studios, within the physical facilities provided by the

University.

Effective Date

ARTICLE 12 - This directive shall enter into force on the date of approval by the Board of Trustees of Yaşar University.

Executive

ARTICLE 13 - The provisions of this Directive shall be executed by the Rector of Yaşar University.
