REGULATIONS ON ANNIVERSARY OF ESTABLISHMENT CEREMONY AND
SCIENCE UNITY SUCCESS
AWARDS

Aim and Scope

ARTICLE 1 - (1) This directive includes the principles regarding celebration of establishment and the award the students, graduates, academic and administrative staff registered at Yaşar University and award the persons and organizations outside the university, who achieved outstanding success in their works.

Calendar of Celebration Preparations

ARTICLE 2 - (1) The celebration preparations of establishment anniversary ceremony of Yaşar University shall begin on the first week of February and the ceremony shall be held on 29 March every year if the academic calendar is suitable.

Celebration Activities

ARTICLE 3 - (1) Social and cultural events and award ceremony take place at the anniversary of Yaşar University's establishment ceremony. The ceremony program and its contents shall be determined by the coordination of the Ceremony Committee and the Award Evaluation Committee and shall be submitted to the approval of the Rectorate.

Celebration Committee

ARTICLE 4 - (1) The celebration preparations of establishment anniversary of Yaşar University shall be organized by Student Council and Alumni Association, under the chairpersonship of the Rector.

Award Evaluation Board

ARTICLE 5 - (1) The Award Evaluation Board consists of the Deans of Faculty, Directors of Institute and Directors of Graduate School and the Secretary General of the University under the chairpersonship of the Rector.

Award Types

ARTICLE 6 - (1) The persons and organizations falling within the scope of this directive shall be awarded the "Science, Unity, Success" awards described below.

- a) **Successful Researcher Award:** Award given to instructors who have made important contributions to their fields with their international studies in science and art.
- b) **Achievement in Education Award:** Award given to academic staff who use educational technologies effectively in associate, undergraduate and postgraduate programs and make a difference with the new approaches and training performance at Yaşar University.
- c) **Successful Student Award:** Award given to students who make a difference with their studies and successful results in associate, undergraduate and postgraduate programs at Yaşar University.
- d) **Successful Alumni Award:** Award given to alumni of Yaşar University who are exemplary for their efforts and achievements and set a good example to students.
- e) **Successful Administrative Staff Award:** Award given to administrative staff with outstanding success in their duties.
- f) **Service Award:** Award given to the academic staff who have completed 5, 10, 15 and 20 years of employment at Yaşar University, due to their service to the University

Awarding

ARTICLE 7 - (1) Service award shall be given as “Certificate of Appreciation” and other prizes shall be given as “Certificate of Excellence”. Award winners also receive corporate identity gifts.

Determination of Candidates

ARTICLE 8 - (1) Candidates are determined by the relevant academic unit for the awards to be given to academic staff, registered and grad students; For the awards to be given to the administrative staff, the candidates are determined by the relevant administrative unit, and the candidates are notified to the Rectorate together with the award candidate files.

Evaluation of Candidates

ARTICLE 9 - (1) The information and documents specified in the award candidate files of the candidates nominated for the award and justifications for their nomination shall be reviewed by the Reward Evaluation Board. The list of nominated candidates who are eligible for the award is confirmed by the approval of the Rector.

Effective Date

ARTICLE 13 - (1) This directive shall enter into force on the date of acceptance by the Senate of Yaşar University and approval by the Board of Trustees.

Executive

ARTICLE 14 - This directive shall be executed by the Rector of Yaşar University.
